- Their key clinical aspects
- Essentials of FCT's understanding of factors which have led to the skyrocketing epidemics and sustainment of these diseases and catastrophic therapy failures of all medical, conventional and alternative approaches. - Scientific confirmation of FCT's tenet of EMF-metals-brain deadly interaction.
- Lest we assume that I am picking only some 'happy' patient cases for presentation, I will also present a case of a young man with some dozen year ordeal of crippling and relentless depression that had never responded to any and numerous treatments. He was filmed in the Basic DVD course in 2004. He was treated with more than a dozen antidepressants and by alternative practitioners/clinics considered to be the best in Europe and the U.S. and treated for Lyme, mercury and many other alleged culprits and all with zero response. At the time of this writing, he is back to being under my care (which he abandoned a few years ago in search for a speedy solution) and is still ill. However, the case is evolving in an interesting and very edifying way. Whether he is still in crisis by the time of this October event or has made progress, I will offer analysis of his course and details of his treatment.
