

DVD – Curable: Lyme disease, co-infections, & Morgellon's

“The microbe is nothing, the terrain is everything.”

Claude Bernard - the great French physiologist of the 19th century, who established a fundamental principle of human physiology – *homeostasis*.

The novel and far superior approach to Lyme with co-infections, and Morgellon's disease was presented by Savely Yurkovsky, MD, in the course of his seminar for health professionals on October 7-9, 2011. It featured patients afflicted with these diseases, none of whom had responded to either conventional, alternative or the combined approaches. Moreover, most of these patients had gotten worse after these treatments.

Why?

Whether you are a patient who has Lyme and co-infections, Morgellon's or any other chronic infection such as herpes, EBV, candidiasis, parasitosis, urinary tract, ENT or genito-urinary and HPV, or you are a doctor who treats infectious diseases, this is what you will learn from this DVD:

- The main focus of treatment by “Lyme-literate”^{*} doctors and by other infectious disease specialists – infectious agents in chronic infections – is a sure path to failure
- Presentation of patients' cases with Lyme disease, co-infections and Morgellon's who had given these treatments years of trial and enormous expense, up to \$100,000 a year to either get nowhere or get worse
- The key handicap of these treatments is their inability to identify and address what counts the most – susceptibility to infectious agents by the host – the patient. And until this susceptibility can be properly addressed, chronic infections remain incurable. How many cured chronic herpes infections has one seen?

To illustrate this key point, if we keep a piece of cheese out of the refrigerator in the summer, it will readily grow molds/funguses and bacteria – infectious agents. No matter how often and with what means – kitchen knife, sophisticated laser beam or antimicrobial solutions– we are to keep attacking these agents, they are bound to regrow. The reason is obvious – we have done nothing to change the susceptibility level of the medium, cheese in this case, to infectious agents.

If one thinks that this example is too simplistic and cannot possibly apply to sophisticated approaches of “Lyme-literate” doctors or the most prestigious infectious disease specialists, one simply does not understand the underlying workings of science or nature underneath our visible, “make sense” events. These workings have nothing to do with the appealing sophistication of treatments, their scientific theories, or professional titles or the number of their proponents. The true essence of science and its main object of study – Nature – lies in underlying concepts and their patterns which are uniform and are re-duplicated throughout however seemingly different manifestations in our reality. That is why fundamental concepts operate similarly in infected cheese and in an infected human body. And if these concepts are not discerned and properly addressed, everything else is doomed to being a marginal science, e.g., something that even if formally scientific, yet of low meaning, ineffective and bordering on being junk science. This is why the current treatments of chronic infections – Lyme with co-infections, herpes, candidiasis, parasitosis, and many others – have failed. Some of many other examples to this point: if antibiotics were the answer to recurrent tonsillitis, why have hundreds of thousands of children had tonsillectomies? Likewise, why did as many children with recurrent ear infections, in spite of even continuous antibiotic treatments, have to have ear tubes inserted. The obvious answer is that antibiotics cannot change the body terrain – the very media for the growth for microbes. Just the opposite, they make it much **worse!** They lead to bacterial resistance, bacterial mutation, destruction of the normal gut and other flora in the body which play a key role in

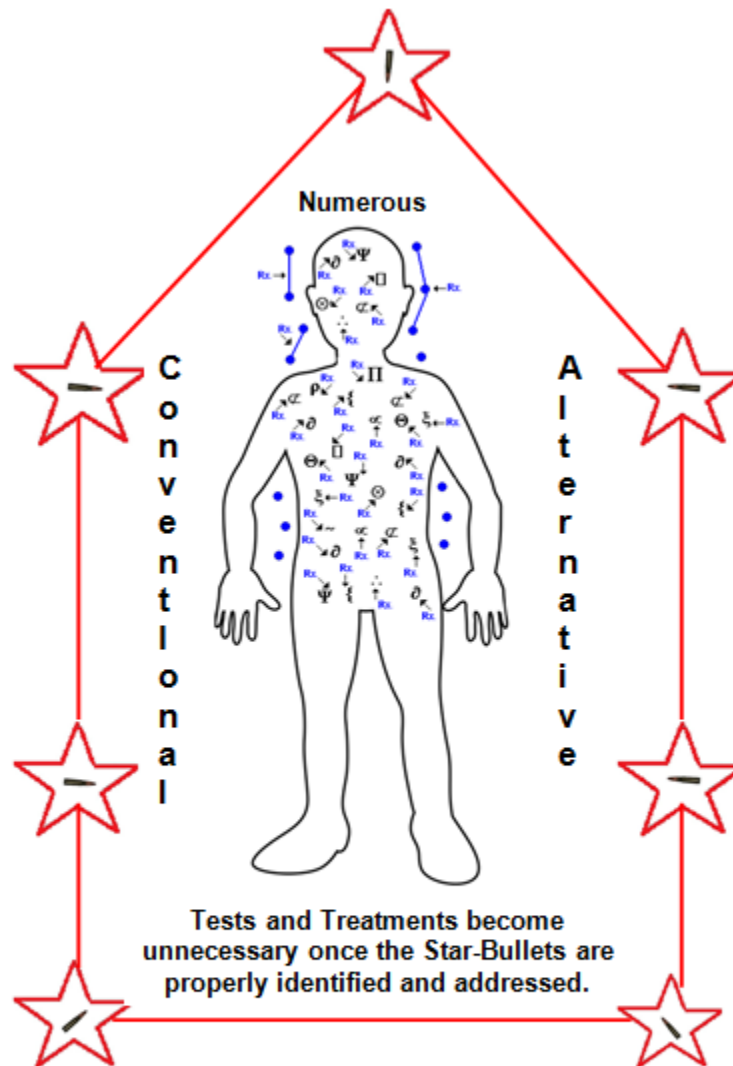

immune stimulation, and lead, also, to overgrowth of other infections, yeasts or bacteria. These **cannot** be prevented or undone through administering yogurt or probiotics. And probiotics have their own side-effects, too, e.g., one cannot keep fixing invisible side-effects of one set of pharmaceutical fixes by another one. If one assumes he can, one is being deluded by “book knowledge” instead of reading the body directly which is only possible through skillful bioresonance testing. So, look at tonsils and ear tube surgeries, or kitchen cheese and learn your lessons – chronic infections cannot be cured by just antimicrobial treatments such as antibiotics, herbs, oxygen, or electrocution. We need to first learn the underlying concepts from simple facts and apply these, afterwards, to other similar facts.

That is why all of these recipes, as presented by “Lyme-literate” doctors in alternative media concerning some “special” bombardments of Lyme and co-infections with “natural” plus multi-antibiotic cocktails is just hype that, in real life, doesn't work. The same with “detoxes”, “chelators”, “immune- or mitochondria boosters” and similar narrow sighted pharmaceutical devinations. These all represent fantasies of their manufacturers and distributors, not true science and actual facts. The peculiar thing about these senseless anti-bug bombardments is not only that these fail but, also, that neither conventional nor alternative specialists, wish to face and explain this simple fact – failure. And one must face the harsh fact that offering a proper explanation for either success or failure is one of the key requirements in science, not my “wise” rule. That is why corporations spend millions of dollars in hiring experts to analyze the roots of their business failures first, instead of just adding more piles of goods. The obvious difference is that, in business, it is the company that pays for its mistakes, but in medicine, the consumer (the patient) does. And an even deeper problem here is not that these medical professional groups do not want to explain the origin of failure – they likely do – but they can't because infectious agents, for them, is not something that we doctors have been trained to understand from broaderevolutionary, toxicological, environmental, and other related perspectives, but something that we have been trained only to bombard. This, among many, constitutes a tragic omission in our training. And, certainly, some “holistic” approaches cannot patch up this big hole.

- While “Lyme-literate” doctors attempt to overcome the low scientific quality of their approach continually increasing piles of their bombs from the co-enzyme Q10 (??!) to oxygen chambers, the stubborn rules of science confront us with some annoying questions such as “can 100 crippled athletes perform as good as a single healthy one or are 100 unnecessary parts necessarily better than a few needed ones. Yes, I am aware of applicable emergent properties where a group of sound measures can amount to a positive effect that cannot be achieved by a single of these measures, but the main difference here lies in the word “sound” and this sound must come from a sound theory which proposes these measures. However, both the theory behind and the measures – Lyme bombardments – all represent broken parts.

The main Star/Bullet morbid factors which cause and sustain chronic diseases and co-infections



Comment: Narrowing down the main causes of disease states to the key – star/bullet factors. Once these are addressed with capable diagnostic and therapeutic means, the disease states dissipate far more effectively, thus obviating countless targets of medical specialties, conventional and alternative.

- Many years ago and throughout the FCT training program over the years, I have expressed the very point of senselessness of antimicrobial bombardments in the article, *“Infectious diseases – what are we treating?”* Because without the understanding of evolutionary mechanisms which have made microbes adapt and survive for billions of years, it is impossible to successfully bombard them into oblivion where practice and medical literature have shown that this only makes the microbes mutate into more vicious forms endlessly. That is why, at the seminar, it was encouraging to present the recent statement of conventional microbiologist and Nobel Prize laureate in medicine who has warned that

microbial agents cannot be and should not be outdone through some pharmaceutical antimicrobial artillery, per se.

- Besides the failure of these antimicrobial approaches, the Nobel laureate and other scientific sources state that these bombardments only compound the problems as they lead to severe side-effects.

Among these, the development of mutated, more resilient and much harder to treat strains. Also, development of other infections and deterioration of the immune system follow as the result of antibiotics or “natural” pills. The paradoxical bottom line: the longer one is being treated with the antimicrobial agents, the more resilient these infections become.

Current epidemics of antibiotic resistant Staph infection (MERSA), E. coli, salmonella and other mutated strains, are solid confirmations to this blindfolded approach to neglecting certain fundamental evolutionary dynamics which have been established between microbes and our bodies for tens of millions of years.

- Recent confirmations concerning the key role that chronic infections play in causing a variety of chronic and degenerative diseases: Alzheimer's, heart disease, arthritis, multiple sclerosis, autism and other. Thus, as it has been stressed by FCT for years, effective identification and management of infectious agents plays a key role in the treatment of **all chronic diseases**.
- Presentation of the key morbid factors – Stars/Bullets – which cause and sustain Lyme and all infectious and chronic diseases.
- Inability of conventional diagnostic tests to identify Stars/Bullets. These bullets paralyze the immune and other key systems and organs which lead to a **permanent** susceptibility state – the terrain – to infectious agents that renders them **incurable**.
- Bioresonance testing of FCT and its key role in identifying overt and latent chronic infections as well as immunosuppressive factors which cause the susceptibility of terrain to chronic infections. The admission of low sensitivity, accuracy and reliability of conventional and all laboratory microbiological methods to properly diagnose infectious agents, as per the aforementioned microbiologist, Nobel laureate in medicine. His experience with bioresonance testing and emphasis on its accuracy and far greater ability in overcoming the deficiencies of the conventional diagnostic methods. It includes him detecting, via bioresonance testing, still ongoing infections even following anti-microbial treatments.
- “Rife” machine – electric bandaid for Lyme and co-infections – and its side-effects. How much does it have to do with Rife himself and the whole “machine” story?

- FCT strategy for Lyme, co-infections and all chronic infections with a primary focus on the immune-suppressive states due to toxicological agents, EMFs (electromagnetic fields), residual side-effects of antibiotics, and other factors, all setting up a state of easily infected terrain. The novel use of homeopathic remedies to address most of these factors.
- Another recent and most impressive scientific evidence on its scale involving some 2.5 million people in the successful use of homeopathic energetic vaccines prepared from the very infectious agents, in the management of one of the most deadly infections known.

FCT utilizes the same principle, once the patient's terrain is ready to respond against the microbes causing Lyme disease, its co-infections or any other infection.

- Below is a statement of one of the presented examples of patients whose Lyme disease and co-infections, as with numerous patients, had been unsuccessfully treated for many years by conventional and alternative Lyme specialists in Connecticut, Boston and New York, prior to FCT treatment.

"I remain on Lyme treatment and babesia treatment

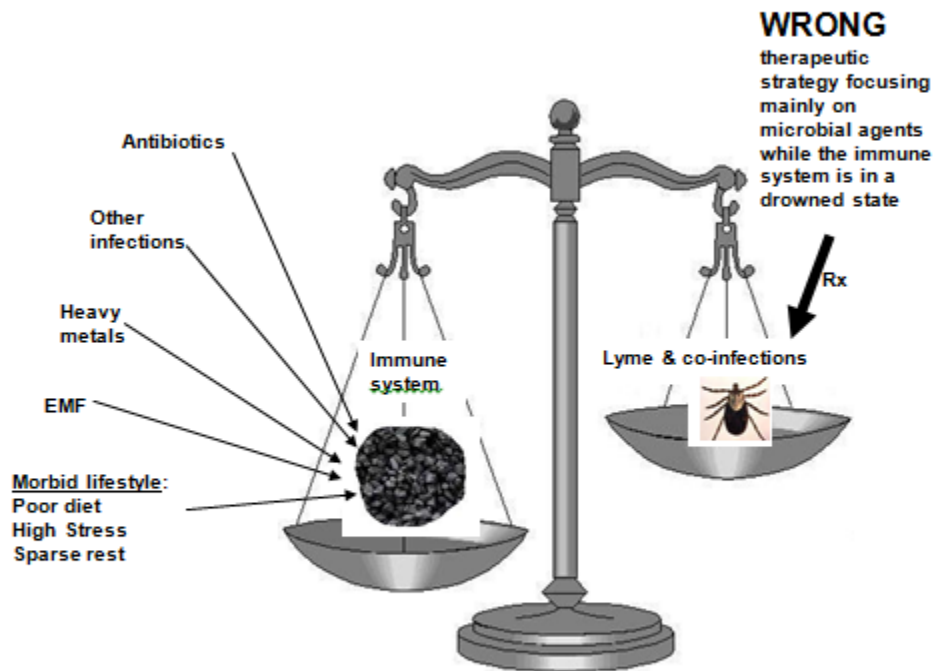
"I am looking for someone who can help me get to the core of what is going on

Lyme and co-infections



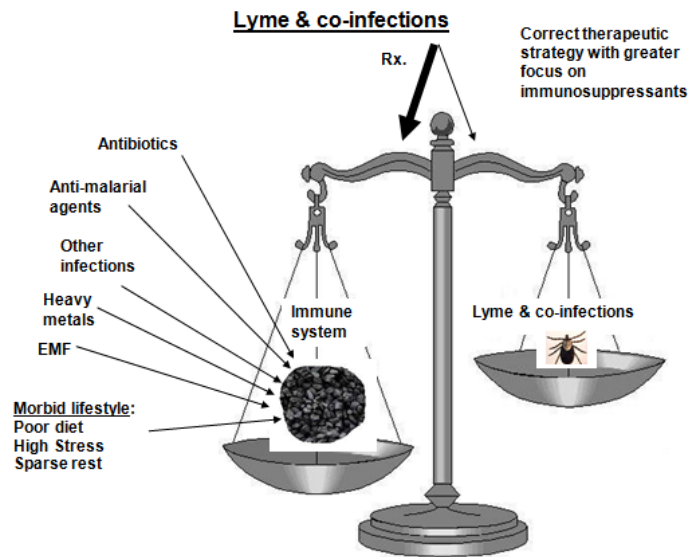
This approach leads to failure due to continuous high susceptibility and low resistance to chronic infections

And the fact is that today, from a bedridden 24/7 invalid, she has gone on to leading practically a normal lifestyle, jogging daily, and undertaking medical studies to become an FCT practitioner.

- Presentation of successfully treated Lyme patients through FCT system with its main focus on the host susceptibility due to immune-suppressive factors present in his body. Among these, a testimony of an MD who became disabled due to Lyme disease and co-infections, multiple chemical sensitivities, chronic fatigue, electromagnetic hypersensitivity with numerous pathologies affecting his brain and body. After conventional and alternative treatments had failed, he was very skeptical about FCT's treating his severe pathologies without any other tests besides bioresonance testing. - **Morgellon's disease**

- This is another mysterious rapidly growing epidemic where patients, besides being afflicted with multiple head-to-toe debilitating medical problems and disfiguring skin ulcers also grow bizarre colorful fibers coming out of their face, scalp, and other parts of their bodies! Who is next?

So far, and as the case with many other chronic diseases, there is no explanation or effective treatments which exist.

- So-called Morgellon's “specialists” and their treatment protocols represent the same band-aids as in Lyme or other chronic diseases where the exact causes – Stars/Bullets – remain unknown. Here, too, a countless number of drugs and supplements are aimed at overcoming this fundamental deficiency – inability to identify and properly address Stars/Bullets.

- Presentation of successfully treated patients with Morgellon's disease through FCT. All of these had been treated unsuccessfully through multiple drugs and as many as dozens of "natural" supplements according to "Morgellon's protocols".
